Moved by Commissioner DeLuca, seconded by Commissioner Markowitz and unanimously carried approving the minutes of the previous meeting.

106/2021 -- A motion was made by Commissioner Foskey, seconded by Commissioner DeLuca and unanimously carried adopting the following resolution:

WHEREAS the Commission has received a request from Manhasset Public School for classification of a new position together with a statement of duties of the proposed new position,

RESOLVED, That the Commission certifies that the appropriate civil service title for the position is School District Treasurer, and be it further

RESOLVED, That subject to the approval of the State Civil Service Commission said position be placed in the Exempt Class, in accordance with Section 41.1 of the Civil Service Law limited to two positions in Manhasset Public School.

WHEREAS the Commission reviewed a resolution from the Great Neck Water Pollution Control District Board of Commissioners requesting permission to change their residency resolution in regards to list certification,

WHEREAS currently residents of the Great Neck Water Pollution Control District are certified to the district first on a list certification,

RESOLVED, That the certification of eligible lists for the Great Neck Water Pollution Control District shall certify candidates from the eligible list in proper score order, with no preference given for Great Neck Water Pollution Control District residency on Civil Service lists, pursuant to §23 4(A) of McKinney's Consolidated Laws of New York.
