The Village of Kensington is requesting the classification of a new position of Police Commissioner in the Unclassified service.

The Village has documented that it is not required to maintain the office of Chief of Police, as described in section 58(1-c) of New York State Civil Service Law. The Village's Police Department was established prior to the 1985 amendment that required each department to have a Chief of Police. The Village has submitted meeting minutes and payroll summaries as evidence establishing that its Police Department was established prior to the 1985 amendment and that the title Chief of Police has never been utilized.

Currently, there are four Villages with a Police Department established prior to 1985 that have never employed a Chief of Police and are allowed either a Police Commissioner or Chairman of the Board of Police Commissioners in the Unclassified service through grandfathering.
